Single sheet paper stock: 80 lb. Minimum. All single sheets that do not meet this requirement must be quarter folded to add weight to the product so it gets inserted without physical damage or tears. An additional charge may be incurred if folding of supplements must be done at our plant.

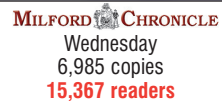

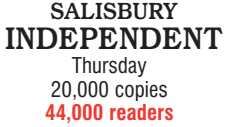

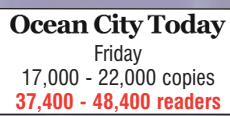
