

# Freshly Insert Program: Shipping Instructions

All inserts must arrive at least one month prior to the agreed month or start date. (Ex: Agreed start date January 1, 2021, inserts must be delivered by December 1, 2020)

#### **Receiving & Shipping:**

- Receiving Hours: Monday-Friday, 8.00am-4.00pm EST (Excludes holidays and unexpected closures)
- **Appointments are required** for all deliveries or pick-ups. These must be scheduled 48hrs prior delivery being completed.
- Please call 267-470-3139 and/or email <u>150warehouse@intellusmktg.com</u> to schedule appointments
- Deliveries without an appointment:
  - o may be unloaded but could result in delays subject to availability.
  - o May be rescheduled at the next convenience. This is done directly with the driver.

## **Delivery Documentation:**

- <u>ALL</u> deliveries must include a bill of lading (BOL) and/or a packing list. Failure to include either will delay the receiving process and may incur additional penalty fees.
- BOL must include:
  - Customer Name
  - Description of materials
  - Quantity of cartons & pallets
  - Pick-up/delivery date
- Packing List must include:
  - Customer Name
  - Description of materials
  - o Size & weight of piece
  - o Item code/URL
  - o Total quantity shipped
  - Quantity per carton

### **Packing Requirements:**

- Pallets <u>MUST</u> 40"x48" with maximum height 48", unless prior arrangements have been.
  Gaylord pallets will <u>NOT</u> be accepted and will incur penalty fees and further delays in the receiving process.
- Include a placard on each pallet. These **MUST** contain:
  - Customer Name
  - Description of materials
  - Total quantity
  - o Number of cartons
  - Quantity per carton
  - Number of pallets
- All cartons for the same SKU should have the same quantities inside and a sample of the item attached outside of each pallet.
  - o Partial cartons are ok. They just need to be highlighted on the packing list and carton label.

### Extra Requirements (If Applicable):

- All floor/bed loaded containers must be scheduled <u>NO LESS</u> than 72hours prior to delivery being completed. These are also subject to higher receiving fees which will be applied on a case-by-case basis.
- All deliveries originating from outside the country must utilize either plastic or IPPC treated pallets. IPPC certification is mandatory.
- Intellus reserves the right to refuse any shipments of damaged or unmarked materials. This may include un-scheduled deliveries on occasion.
- If the above requirements are not satisfied, repeated noncompliance may result in penalty fees.
